Travel and Conference Expenses

WRISE will cover the following expenses for the recipient of the award:

- Economy airfare for the recipient to attend the WRISE Leadership Forum in Atlanta, GA from October 14 through October 16, 2025 (the "Forum").
- A maximum of 3 nights at the Forum's official hotel (The Atlanta Hilton) or a nearby hotel if the official hotel is unavailable.
- Registration fee for the Forum.
- Incidentals normally associated with travel, such as taxi from airport to hotel.
- The recipient will submit a request for travel reimbursement and include all appropriate documentation including receipts and statements.
- The maximum amount covered is \$4770 including the registration fee and hotel booking. The recipient will be responsible for any costs over the maximum amount.
- All travel and hotel expenses must be reasonable. In WRISE's sole discretion, any travel or hotel expenses considered excessive will not be paid for or reimbursed.
